TOWN OF EAST BEND NORTH CAROLINA BUDGET ORDINANCE

WHEREAS, after notice and a public hearing pursuant to statute, the Board of Commissioners of the Town of East Bend wish to adopt a Budget Ordinance for the fiscal year beginning July 1, 2020 and continuing through and including June 30, 2021;

NOW, THEREFORE, BE IT ORDAINED by a unanimous vote of the Board of Commissioners of the Town of East Bend as follows:

- 1. The fiscal year budget is set forth on Exhibit "A", attached hereto and incorporated by reference.
- 2. The funds appropriated for each general fund account shall be appropriated from the general fund, and the funds appropriated for each water fund account shall be appropriated from the water fund.
- 3. The Budget Officer shall not be authorized to transfer funds between departments except as authorized by the Governing Board.
- 4. The estimated revenue accruing from ad valorem taxes for the fiscal year is based on a tax rate of fifty cents (\$0.50) per one hundred dollars of assessed taxable valuation of property listed for taxes, and there is hereby levied a tax on real and personal property at the rate of fifty cents (\$0.50) per one hundred dollars of assessed taxable valuation of property listed for taxes.

This Ordinance is effective as of the date of its adoption.
